## Shri. Satish Magar, President, CREDAI NATIONAL

- Subvention scheme are back, but do we have money to serve the interest. hence we suggested an idea to Finance Ministry that why can't HFC funds the home loans if customer pays 30% instead of 20% and after 2 years this extra 10% can be adjusted with accured interest. This way Builders won't be burden nor customer.
- Keep our teams motivated during this time. Not with the senior management but with the junior management.
- Be transparent with them about Salary too as there will are no income during this period.
- Be with them Transparent in the same page.
- This is how we build the ecosystem.

#### Direct and Indirect taxes are 32%. Instead can we pay via lien on flats

We need to suggest to the government to take progressive payment. This can be monitored through the RERA as everything is updated on Maharera. So if the flat is sold proportionate to that payment will come to government.

Once lockdown is over, we need to approach to the State Government with our demands

**Getamber Anand** – for next 6 months no one will go to NCLT as per discussion with the Finance Ministry.

- (A) Getamber Anand The thought proces of RERA chief is getting changed, even they are of thought that they can't pass an order for a refund. The project should get completed. ## (Q) Can you bounce back five ideas

## (A) Getamber Anand -

- 1) Stay out of things unnecessary work, focus only on core competencies
- 2) People who are in the system for many years but they are resisting change we need to let them go
- 3) Changing times on IT, why don't you have 5 days a week. To keep Saturday off. CRM can work from Home with Zoom platform. IT will play a major role. Also an option of Friday being off i.e Work from home. So that
- 4) Need an analytical team to come and analyse on various verticals over the past 5 years. Make analysis out of it. Make Analysis on Sales data/ Fiance data of last 5 years and make strategy of it. For e.g Why spend unnecessary on marketing 4% to 5% hoarding everywhere without being analyse where the actual geographical locations customers are coming from.
  - 5) We are over paying, thinking we will not get good talent.

Demanding for Housing will increase for sure. Job Security amongst people is the major issue.

President – Supply Chain – We need to get the demand coming up.
